TIPO's New Measures in 2014

As an effort to expedite the patent acquisition on environmental sustainability, provide a more convenient patent/trademark application procedure and increase the transparency of copyright licensing market, TIPO has launched new measures as follows since January 2014: 1.Accelerated Examination Available for Green Tech Patent Application (1)In the cause of encouraging the green technology related invention applicants to utilize the AEP, request can be submitted by any invention application qualified for the following alternatives: a.The technical field involving energy conservation, new energy, or new energy vehicles, etc b.The invention involving carbon reduction or resource- saving. (2) Applicants only prepare relevant documents for the green technology application and filing fee of NT\$ 4,000. The first office action can be issued within 9 months by TIPO as long as all necessary documents are completely filed. 2.Electronic Service of Patent/Trademark Documents Applicants or agents need to complete the following steps, inclusive of obtaining the e-certificate, registering as a member of TIPONet, signing the online agreement for electronic delivery/receiving and downloading E-SET, and then TIPO will deliver the relevant communication documents of patent/ trademark prosecution via E-SET. 3.Word Add-ins Make E-Filing more User-Friendly As the most used software for applicants in Taiwan is MS Word, TIPO has completed the related Word Add-ins functions, which are up and running online in mid-January 2014. By using Word Add-ins, applicants can compile the application, specification and chart. Moreover, all word files can be directly converted into PDF files for electronic filing. In April, more functions such as goods category selection, contact, image editor, fee calculation and application form guidance will be completed, and the whole process will become easier. 4. Online Search System of Copyright Collective Management Launched for Radio Stations Established by TIPO, the prototype of online search is open to be examined from January to June 2014 for radio stations and Copyright Collective Management Organization (CMO), and an educational training was held for both parties in January. The end purpose of the system is for users and CMOs to look up and countercheck in the database and aims at making copyright licensing market more transparent through information disclosure that helps build a fair and reasonable payment mechanism.



2013 U.S. Design Patent Seminar

On December 9, 2013, TIPO held the U.S. Design Patent Seminar, inviting Mr. Joel Sincavage, design practice specialist and Mr. David Gerk, patent attorney of USPTO, to introduce the U.S. design patent system, the direction of amendment for future industrial design protection and case study of design patent examination.



SIPA Delegate Visits TIPO

Shanghai Intellectual Property Administration (SIPA) Director General Mr. Lu Guoqiang led delegates of 5 people to visit TIPO Director General Ms. Wang Mei-hua on December 10, 2013. Both sides shared experiences in regard with IPR business, legal system and industrial policy and so on.



Classification and Cross Reference Index for Goods and Services Available Since January 1, 2014

In compliance with the implementation of the 10th edition of the Nice Classification on January 1, 2014, TIPO amended "Classification and Cross Reference Index for Goods and Services" as well as 24 remarks that are promulgated and carried out at the same time. If the designated goods or services, which are of the trademark registered through e-filing, comply with the latest amendment, then the deduction of NT\$300 per class will be granted.



TMCS Royalty Rate for Satellite TV Channels Reviewed

To build a reasonable licensing environment, TIPO has reviewed TMCS royalty rate for satellite TV station channels in 2013 as follows: 1.Music Channel: 0.1% of the sum of the advertising revenue plus the royalty revenue (hereinafter referred to as royalty received from all cable TV stations) in the preceding year as the royalty of the year. 2.General Commercial Channel (comprehensive channels): 0.05% of the sum of the advertising revenue plus the royalty revenue in the preceding year as the royalty of the year. 3.Cinema, Cartoon Channels: 0.025% of the sum of the advertising revenue plus the royalty revenue in the preceding year as the royalty of the year. 4.News and Sports Channels: 0.01% of the sum of the advertising revenue plus the royalty revenue in the preceding year as the royalty of the year. 5.Educational, Religious and Public Beneficial Channels: 0.007% of the sum of program production cost (including news production cost and drama production cost) plus communication cost for broadcasting (satellite uplink cost). 6.Governmental Channel (ex. Aboriginal Channel, Hakka Channel): 0.02% of the budget allocated by the government. 7.Shopping Channel (satellite or cable transmission included): 0.05% of the 30% of the gross profit in the preceding year The above-mentioned royalty rate includes the sum of royalty from programs and/or advertisements of satellite broadcasting program supplier as family subscribers review in the course of public broadcasting.



TIPO Hosted 2013 Symposium on Biological Material for Patent Application

The symposium of TIPO-commissioned DCB's research project Biological Material for Patent Application took place at NTU's Tsai Lecture Hall on December 2, 2013. Two lawyers of Dick W.C. Lai and Ben C.Y. Liu were invited to introduce patent licensing and application in practice. The relevant contract template and checklist of biological material transfer licensing were addressed to help involved parties for drawing up a contract. Besides, the accomplishments of TIPO's Value Added Network for Patent Biological Material Application and value added technical assistance in the past 2 years were well presented. More than 109 specialists in the industry, government, academy and institute attended this symposium and indicated they had better understanding about related regulations for the information revelation of patent biological material, value added technical assistance and biological material transfer or application in this symposium, which is helpful to activate the domestic biotechnology industry.



Elite Forum of Telecom Technology Patent Trends and Patent Litigation Analysis Held

The Elite Forum of TIPO-commissioned NARLabs STPI project on Telecom Technology Patent Trends and Patent Litigation Analysis took place at NTU's Institute of Applied Mechanics on December 3-4, 2013. The topics consists of "Development and Opportunity of 4G/5G Technology", "Specific Approach of Corporates' Participating in 3GPP SSO", "Analyses for Asian Key Enterprises' Portfolio of Standard on Mobile Communication Technology", "Taiwan Companies' Strategy for Competition on Mobile Communication Industry", "Litigation Walkthrough with SEPs and FRAND/ RAND", "Analysis on NEPs' Coercion with SEPS and on New Counterattack by Corporates" and "Taiwan Companies' Countermeasures Dealing with U.K. and European Patent Litigation" and so on. Also, a panel discussion, hosted by TIPO Director General Ms. WANG Mei-hua, had attendees of specialist including General Counsel Mr. Wei-Fu Hsu of Mediatek, General Counsel Mr. Vincent Hong of ASUSTEK, Mr. Ming-Tao Yang of Finnegan LLP and Mr. Ya-Chiao Chang of Kirkland & Ellis LLP to discuss "How to use SEPs and FRAND/RAND for royalty negotiation?" All participants agreed that taking part in SSO is helpful for domestic companies to better understand the development of technology and that possessing SEPs should be beneficial for a company to increase bargaining chips on licensing. A total of 450 field and corporate professionals attended the Elite Forum, which may prepare the SMEs for subsequent patent portfolios.
