2. Bank transfer (ATM, online ATM, online transfer, mobile payment), telegraphic transfer, or payment at any branch of the Taiwan Cooperative Bank by completing an "Interbank Deposit Note": For confirmation purposes, please make payment to the account number on the payment slip provided by TIPO for payment.

3. Bills: Limited to sight drafts (checks, drafts, or bank drafts with the date on the bill not later than the date of receipt by TIPO), payable to " Intellectual Property Office of the Ministry of Economic Affairs" and please label the bill as "non-negotiable".

4.郵政劃撥：劃撥帳號 00128177、戶名為「經濟部智慧財產局」，劃撥單通訊欄請加註「商標註冊申請案」、「申請人名稱」、「商標名稱」、「聯絡電話」等項目（俾便聯絡），本劃撥帳號請勿以電匯或轉帳方式辦理。寄件地址：臺北市大安區辛亥路二段 185 號 3 樓。

4. Postal remittance to the order of "Intellectual Property Office of the Ministry of Economic Affairs" at A/C 0012817-7, indicating reference number, applicant's name, name of the trademark, and contact telephone number (for correspondence). Postal remittance should be sent to 3F, No. 185, Sec. 2, Xinhai Road, Da'an District, Taipei City.

5.信用卡：以信用卡進行線上繳納規費，持卡人與 e 網通會員需為同一人。繳款人於 e 網通選擇繳費方式，輸入信用卡資料及 3D 驗證碼，

經檢核成功即完成繳納程序。

5. Credit card: For online payment with credit card, the cardholder must be the TIPONet member. After selecting credit card payment on TIPONet, input credit card information and the 3D verification code. The payment process is completed after verification.

6. 約定帳戶扣繳：

(1)請依照約定帳戶扣繳作業須知填妥「全國性繳費(稅)業務授權轉帳繳款申請書」寄送本局，由本局轉送開戶金融機構進行核印手續(請勿自行繳交至金融機構)。

(2)約定帳戶辦理時間約 10 個工作天(依各金融機構作業時間為準)，請於接獲本局電話及 Email 通知約定扣繳帳戶成功後，再依照「使用約定扣繳方式繳交各項規費」所列程序繳納規費。

(3)請依該作業須知選擇線上或紙本扣繳方式辦理各項規費之單次扣繳。

6. Authorization to charge a deposit account on a regular basis:

(1) Please complete the "Nationwide Bill (Tax) Payment Direct Debit Application Form" according to the instructions for authorization to charge a deposit account on a regular basis. Send the form to TIPO for forwarding to the designated financial institution for processing (do not submit directly to the financial institution).

(2) The processing time for directly charging a deposit account is approximately 10 working days (subject to the operating hours of the respective financial institution). Upon receipt of notification by phone and email from TIPO confirming the successful s

etup of a designated account for direct charging, please pay fees according to instructions from the "Fee Payment Via Authorization to Charge a Deposit Account".

(3) Please select either online or paper-based deduction for each payment according to the **instructions** provided.
