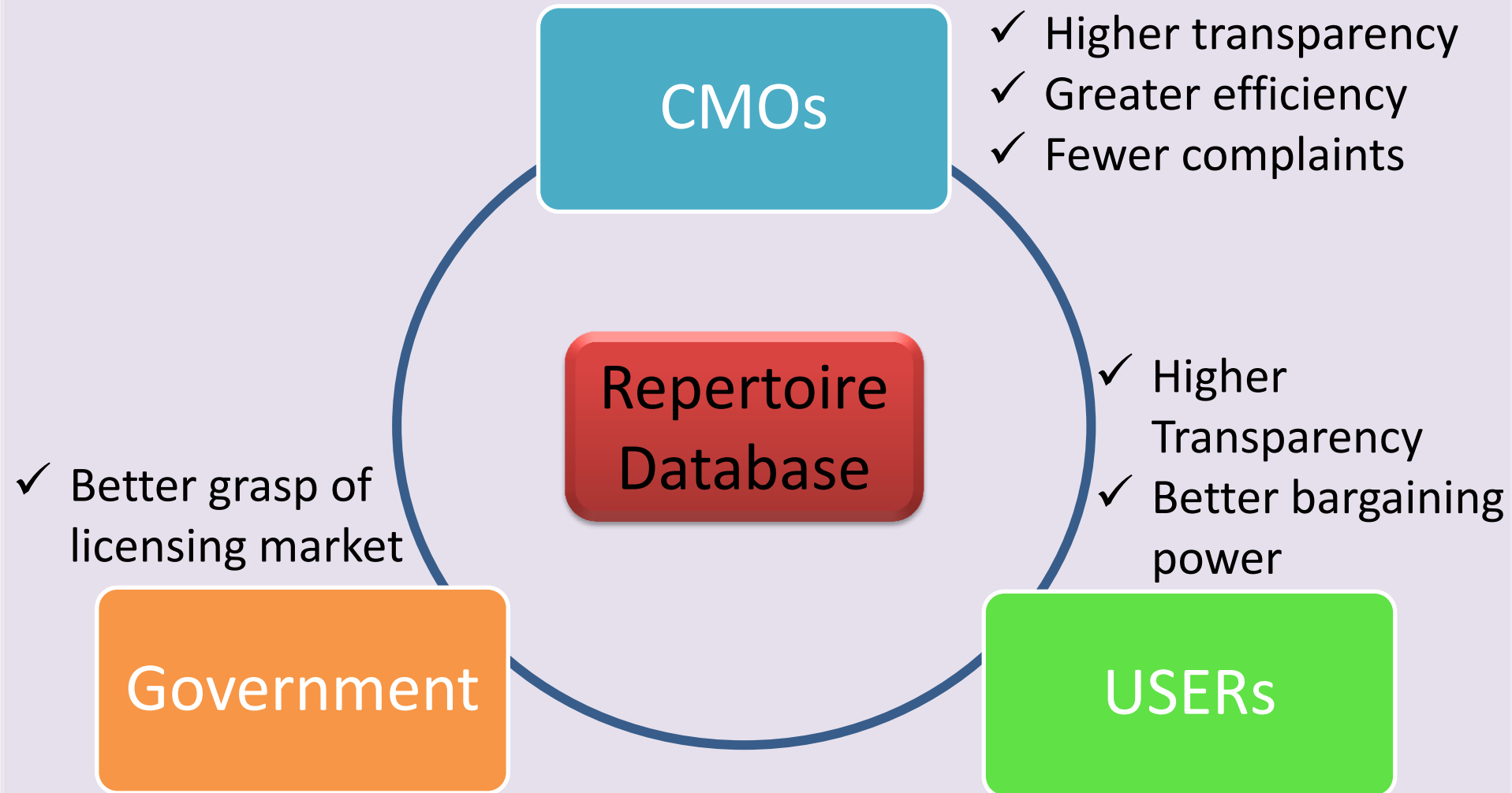

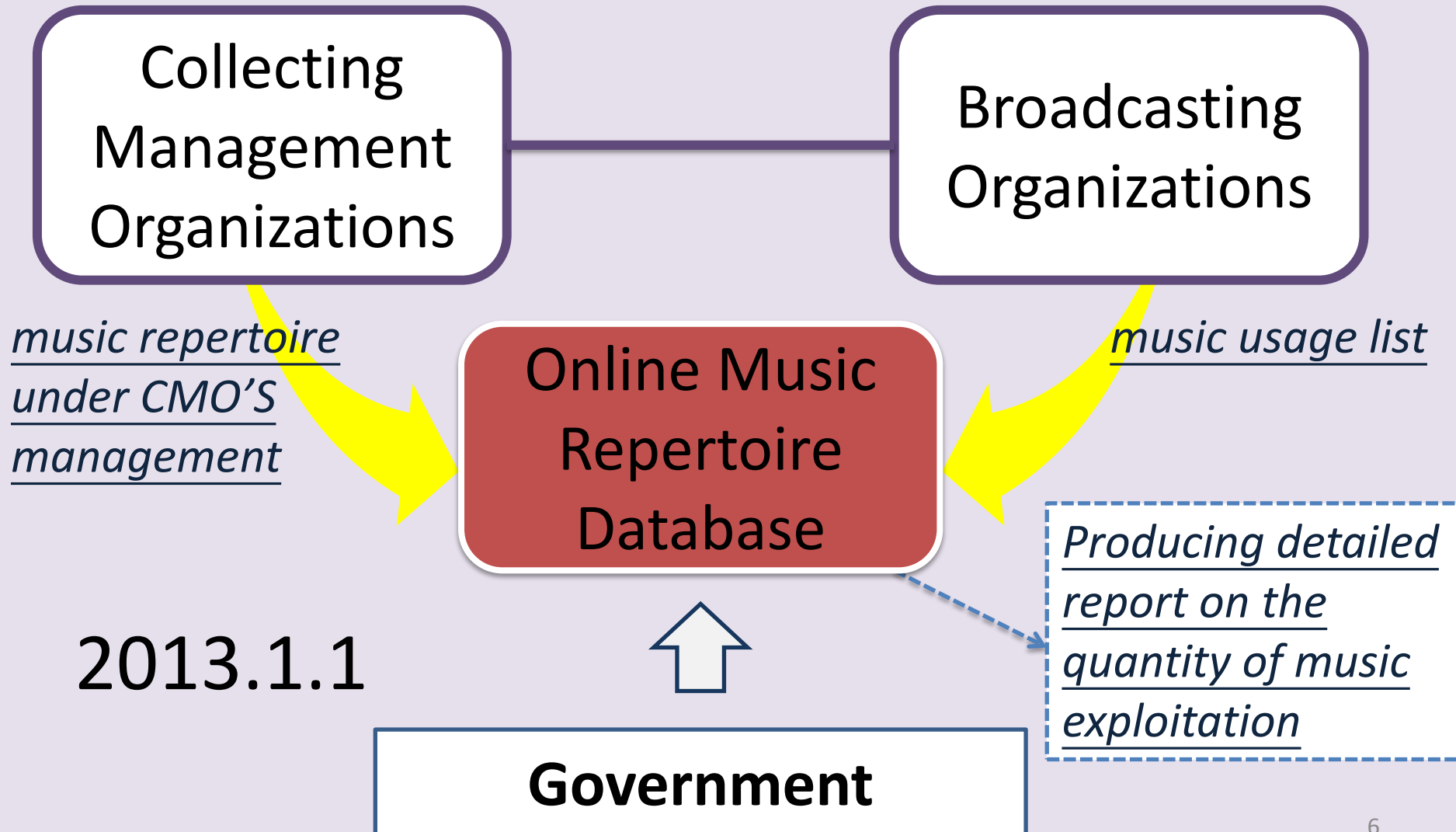
# Reasons for Creation

1. Existing tariff criteria of radio license is based on **Location & Level of music usage & Power of radio station**
2. Licensee complaint the tariff is inconsistent with actual **Quantity of the music exploitation**
3. Request the government to build **Online Music Repertoire Database** designed to:
  - (1) upload all the music works and sound recordings under the management of CMOs;
  - (2) provide instant mapping system to show all the music managed by CMOs and used by radio station

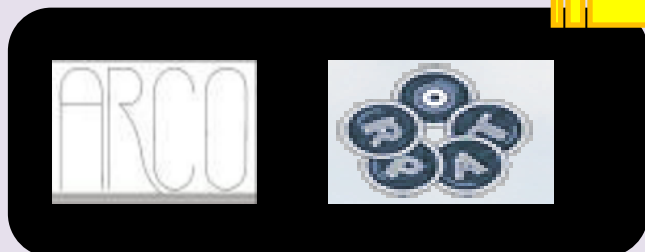

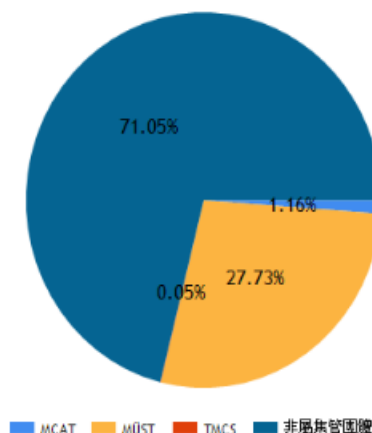

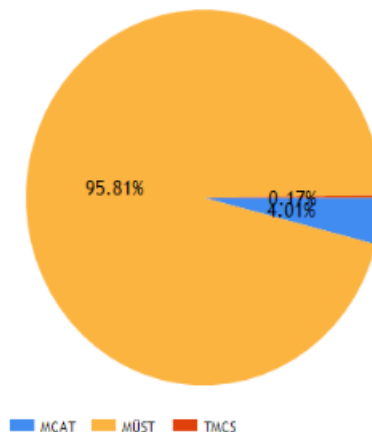

# Benefits

- ✓ Enhance transparency for both radio stations and CMOs
- ✓ Minimize the occurrence of dispute over tariff and speed up licensing process
- ✓ Facilitate a rational and objective tariff negotiation

# Future

- Aim to extend over other industries, e.g., TV industry, and create a transparent licensing market
- Connect with other identity system (ex.ISWC, ISRC) , to get more explicit identification and keep in line with international standard
- Lay the foundation for creation of future voluntary online licensing system and convenient licensing environment
